- Participating dealers must be enrolled in the LG HVAC Pro Dealer Program with LG and the LG HVAC Home Design program with Synchrony and have Platinum tier status..
- Participating LG Pro Dealers must be enrolled and maintain eligibility in LG Electronics U.S.A., Inc.'s Air Conditioning Technologies LG HVAC Pro Dealer Program.
